ESPRICO[®] is a dietary food for specific medical purposes (balanced diet), for the dietary treatment of AD(H)D (attention deficit/hyperactivity disorder) accompanied by poor concentration and learning difficulties.

ESPRICO[®]

ESPRICO[®] has been developed on the basis of present scientific knowledge specially for the nutritional needs of children suffering from AD(H)D. The fruity suspension contains sea fish oil with a high concentration of omega-3 and omega-6 fatty acids. As a result, **ESPRICO[®]** is particularly rich in polyunsaturated fatty acids. It also contains the minerals magnesium and zinc.

ESPRICO[®] consists of a balanced blend of sea fish oil and evening primrose oil and is therefore rich in polyunsaturated fatty acids. **ESPRICO[®]** thus fits the specific nutritional needs that children with AD(H)D have and meets their medical nutritional requirements. Based on the specific needs of AD(H)D children, the mineral and vitamin content in **ESPRICO[®]** has been selected so as to meet these needs. In addition to this, it has an increased content of magnesium and zinc.

Omega fatty acids

Omega-3 fatty acids are polyunsaturated fatty acids and therefore essential fatty acids. Essential because we are not able to produce these fatty acids by ourselves, but can't live without them either!

An unbalanced diet or irregular eating habits can quickly lead to an imbalance in the amount of fatty acids we consume with our food. By eating fish (for example, herring, tuna, mackerel and salmon), various plant oils and green vegetables, we can give the body the fatty acids it needs.

In this instance, the omega-3 fatty acids EPA (eicosapentaenoic acid) and DHA (docosahexaenoic acid) as well as the omega-6 fatty acid GLA (gamma-linolenic acid) are worth mentioning in particular.

Minerals

Minerals such as magnesium and zinc have to be supplied via the food we eat, as the body itself is unable to produce minerals. Minerals come from neither animals nor plants, but are inorganic and usually metallic.

Good providers of magnesium are whole grain products, soy beans, manioc and Alaskan pollock.

Good sources of zinc are beef, various types of cheese, egg yolks, pork, turkey, duck and pheasant.
